Background:

Southampton plc has been negotiating a contract with a potential customer in Russia. Before the negotiation started, the Russian company requested that it should be allowed to make the statement of Southampton. These statements were included the costs of sending the technical staff to Russia. This is the first report under the company's new contract with a new customer. The previous contract under which the customer was trading started the first strategy was to concentrate on business in the UK.

Comments from management accountant

Point 1: This report will not stand for the contract.

Point 2: This figure does not include £100,000 of costs for goods that have already been received. This is the cost of sending engineers to Russia to help with the negotiations.

Point 3: This is 50% of the cost of expenditure. It is suggested that the expenditure will appear about half the price on the contract. This cost does not include a £10,000 bonus for the customer if the contract is completed on time.
