Recent developments in information technology (IT) have had a tremendous Rimpact on the field of auditing. IT has inspired the reengineering of traditional business processes to promote more efficient operations and to improve communications within the entity and between the entity and its customers and suppliers. These advances, however, have introduced new risks that require unique internal controls. They have engendered the need for new techniques for evaluating controls and for assuring the security and accuracy of corporate data and the information systems that produce it.

This chapter provides an overview of IT auditing. We begin by describing the various types of audits that organizations commission and distinguish between the auditor's traditional attestation responsibility and the emerging field of advisory services. We go on to explain the structure of an IT audit: the relationship between management assertions, audit objectives, tests of controls, and substantive tests are explained. The chapter also outlines the key points of the COSO control framework, which defines internal controls in both manual and IT environments. The final section of the chapter examines audit issues and implications related to Sarbanes-Oxley legislation and provides a conceptual framework that links general controls, application controls, and financial data integrity. This framework is a model for the remainder of the text.
