

Level 1

Level 2

"Food Safety" introduces intermediate standards for various food types, builds on Level 1 requirements, and is based on Hazard Analysis and Critical Control Points (HACCP) regulations.

Level 3

"Food Safety and Quality" is the gold standard of SQF certification, building on Levels 1 and 2, with corrective actions addressing identified risks and demonstrating a strong emphasis on both quality and safety.
