communism and when added to the failure of the left and liberals in the region it has paved the way for far right and neo fascist political movements to emerge claiming the mantle of defenders of society from the market This represents a fundamental threat to the enlightenment traditions that have shaped dominant modern political ideologies and raises profound problems for both the EU and NATO
