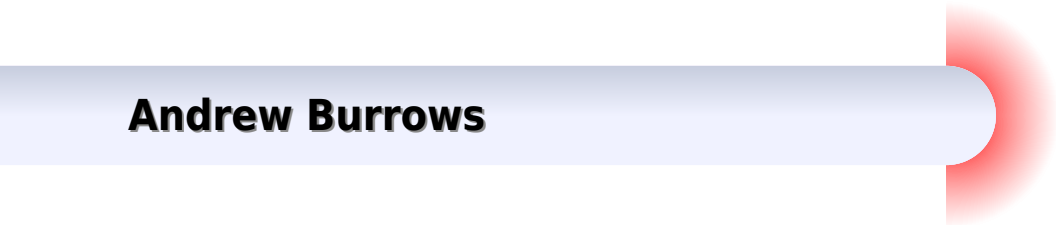
Point 1: This report will not stand for the contract.
