She should not make an investment in Starting Right. I would recommend that Sue Pansky should invest in corporate bonds for the reason that her investment of \$30,000 is protected to the degree of \$20,000 while this amount has been guaranteed by Julia whereas; she attains a steady income at the rate of 13 percent per year.

Question 2

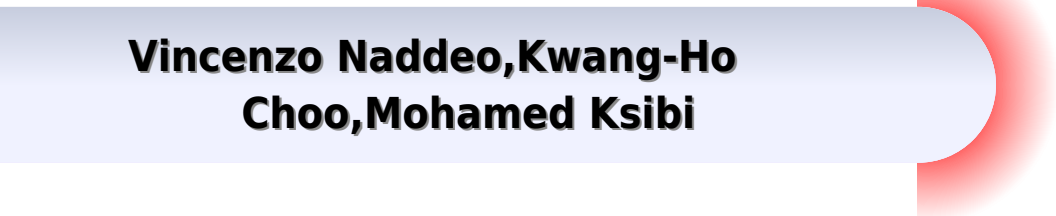
