Internal Control Weakness and Cost of Equity Maria Ogneva,2012 Section 404 of the Sarbanes Oxley Act SOX requires every company to report on the effectiveness of internal controls over financial reporting Section 404 has arguably been the most controversial provision of SOX with many registrants complaining that the high cost of compliance outweighs its benefits In contrast the SEC and others have argued that the Section 404 provisions are beneficial to the capital markets and will eventually reduce the cost of capital In this paper we examine the association between implied cost of equity and internal control effectiveness for firms that filed Section 404 reports with the SEC We find marginally higher cost of equity for firms disclosing material weakness in internal controls than for a sample of firms disclosing no material weaknesses The differences in cost of equity disappear after controlling for firm characteristics associated with firms disclosing material weaknesses Overall our results are consistent with internal control weakness identified under Section 404 not being directly associated on average with higher implied cost of equity
