 - o **The federal framework:** What rules govern the resolution of conflicts between Commonwealth and state laws? What immunities do Commonwealth and state governments enjoy?
 - o **The separation of powers doctrine:** How are legislative, executive and judicial powers defined and separated under the Commonwealth and state constitutions? (tripartite separation of powers)
 - o **Constitutional rights:** What are the foundations and scope of the express and implied rights conferred by the Constitution?
