

COMMUNITY RESIDENTIAL CARE PROGRAM

1. PURPOSE: This Veterans Health Administration (VHA) Handbook is a revision of the Community Residential Care (CRC) Handbook 1140.01. It provides the procedures necessary for conducting VA's CRC Program.

2. SUMMARY OF CHANGES: This revised Handbook:

- a. Clarifies the procedures for referring Veterans to CRC facilities.
- b. Clarifies that all VA placements into CRC facilities must be approved by the CRC Coordinator, the MPH Coordinator or designees.
- c. Describes changes in the reporting procedure for adverse and sentinel events.
- d. Includes references to Medical Foster Home as a form of CRC.
- e. Describes a new requirement that the Women's Veteran Program Manager at the VA medical facility is available as a consultant to the CRC program and the CRC interdisciplinary inspection team.

3. RELATED ISSUES: VHA Handbook 1141.02, VHA Handbook 1108.07, and VHA Handbook 1108.05.

4. RESPONSIBLE OFFICE: The Office of Patient Care Services, Geriatrics and Extended Care (OPHC), is responsible for the contents of this Handbook. Questions may be directed to 202-461-6751.

5. REVISIONS: VHA Handbook 1140.01 dated March 29, 2007, is rescinded.

6. RECERTIFICATION: This VHA Handbook is scheduled for recertification on or before the last working day of February 2019.
