The general rule is that the amount of costs is based on the tariff set out in Appendix H of the Supreme Court Rules, plus disbursements. Occasionally, if there has been reprehensible conduct in the course of the action, such as fraud, the court may order that "special costs" be paid to the supressful party. Special costs are higher and approximate actual legal fees. You can apply for special costs even if you are not represented by allowyer.

You must make a claim for costs in your notice of civil claim, or in your notice of application, when you make anapplication in charabers.
