The book then delves into such topical issues as the relationship between competition for natural resources and international investment law, the UN Global Goals and the fledgling international climate change regime with particular emphasis on the Paris Climate Agreement and their implications for developing countries. As is often the case in such circumstances when the WHO is denied resources to assist those countries or the WTO is unable to guarantee access to Covid 19 medical supplies and protective equipment, it is the poorest nations that suffer the most. EtYIL's mission is to provide a platform for purpose-oriented scholarly analysis and debate on issues of particular significance for African countries such as Covid 19 disputes over Nile water resources and Ethiopia-Eritrea relations. EtYIL 2019 also addresses a number of other topical issues including the responsibility of the UN Security Council (UNSC) in climate-related risks to least developed countries, the Global South's approach to environmental protection, the challenges of international regulation of arms brokering and the contributions of Martin Luther King Jr to Pan-Africanism and international human rights law. Finally, the Yearbook also continues its coverage of regional issues such as the evolving Ethiopia-Eritrea relations, Djibouti's accession to the ICSID Convention, the trilateral negotiations between Ethiopia, Sudan and Egypt over the Grand Ethiopian Renaissance Dam and the US meddling and the role of the UNSC on the issue.
