- Risk and Exposure: Risk is defined as the uncertainty of loss. Exposure refers to situations that
  present the possibility of loss, such as owning a house in a flood-prone area.
- Managing Risk: There are four primary methods:

  - Pure vs. Speculative Risks: Only pure risks (possibility of loss only) are insurable.
     Speculative risks, which involve the possibility of gain or loss (e.g., gambling), are not insurable.
  - Insurable Interest: The insured must have a financial interest in the property or person being insured.
- Other Insurance Terms:
  - Peril: The cause of loss (e.g., fire, theft).
  - Hazard: Anything that increases the chance of loss (e.g., faulty wiring is a physical hazard).

#### Unit 2: The Insurance Contract

- Elements of a Valid Contract:
  - Competent Parties: The parties involved must be legally capable of entering into a contract (e.g., not minors, intoxicated, or mentally incapacitated).
  - Legal Purpose: The contract must be for a lawful purpose (e.g., you cannot insure illegal activities).
  - Offer and Acceptance: One party makes an offer, and the other accepts it. In insurance, the offer is the application, and acceptance is the issuance of the policy.
