INSTRUCTIONS

1. The application form must be completed (typed) and signed by the Postdoctoral Fellow.
2. In order to qualify for a Vaal University of Technology Postdoctoral fellowship, the following criteria will be considered during the selection process:
 - Candidates must be available for **FULL-TIME RESEARCH** at the Vaal University of Technology.
 - Candidates will be awarded a tenure of one year only that is renewable for a maximum of two years, subject to satisfactory performance and motivation from the respective Principal Investigator (PI)/Host.
 - The Fellowship is valued at a tax exempt **R300, 000.00** per annum (Three Hundred Thousand Rand), and there are no benefits attached to this remuneration.
 - Candidates must have obtained their doctoral degrees within the **LAST FIVE YEARS** (2017 being the latest date of the degree being awarded).
 - Fellowships are awarded on a competitive basis, taking the Applicant's academic achievements and a good motivation as researcher into account. Applicants are encouraged to ensure that a full list of their publications is included in the CV section of the application form.
 - As the fellowship is primarily to enable the Postdoctoral Research Fellow (PDF) to focus on research, the fellowship holder may **NOT HOLD FULL-TIME SALARIED EMPLOYMENT** concurrently with tenure of the fellowship, however he/she will be allowed to undertake a maximum of twelve hours per week of teaching related work.
 - All awardees will be required to enter into a signed agreement with the Vaal University of Technology.
 - Any qualification obtained outside South Africa should be evaluated by the South African Qualification Authority (SAQA) and proof thereof must accompany the application.
 - It is the responsibility of the PI, to identify, screen, interview (with an interview panel) and select potential post-doctoral research fellows. Proof of the interview or screening method must be attached to the application form.
 - Once this selection process has been completed, all completed documents must be submitted to the Research Directorate for necessary processing.
 - Please note that there is little purpose in pursuing an application unless there is a clear commitment by a department to provide necessary facilities (office space, lab equipment etc.).
3. Applicants may submit these documents via email to their potential Principal Investigator (PI)/Host or to Mr Mahlaule Vulani
4. The PI must submit completed forms with all the necessary documentation to Mr VC Mahlaule (vulanim@vut.ac.za) in both physical and electronic form.
