It looks at shorter term movements as the public approves or disapproves politicians, trusts or distrusts government. It is distinctive in that it focuses always on locating the unobserved true opinion that lies beneath, turning away from the superficial polls by which we come to know the real thing. It argues that public opinion is decisive in American politics and it locates the citizens who produce this influential change as a quite small subset of the American electorate.

Its most basic premise is that although public opinion rarely matters in a democracy, public opinion change is the exception. Public opinion rarely matters because the public rarely cares enough to act on its concerns or preferences. Change happens only when the threshold of normal public inattention is crossed. When public opinion changes, governments rise or fall, elections are won or lost, and old realities give way to new demands.
